<p><b>13. Taxes refunded for years preceding tax year 2015.</b> Enter the amount of taxes refunded by the district for tax years preceding tax year 2015. <p>B. 2016 value of properties not under protest or included on certified appraisal roll. The chief appraiser gives school districts a list of those taxable properties that the chief appraiser knows about, but are not included in the appraisal roll certification. These properties are not on the list of properties that are still under protest. On this list of properties, the chief appraiser includes the market value, appraised value and exemptions for the preceding year and a reasonable estimate of the market value, appraised value and exemptions for the current year. <b>25. Maintenance and operations (M&amp;O) rate.</b> Enter \$1.50 OR the 2005 adopted M&O rate if voters approved a rate higher than \$1.50.	\$1.5000/\$100

Debt also includes contractual payments to other school districts that have incurred debt on behalf of this school district, if those debts meet the four conditions above.
