We want you to know that we are sympathetic to the current economic situation we all find ourselves in.

However, the Texas Property Tax Code requires the appraisal district to appraise all property at its market value as of January 1 of each year.

It is vital that our values are representative of that January 1 value because school funding may be reduced if the Comptroller's Property Tax Assistance Division determines that the appraised values of a school district fall outside of their confidence interval.

#### **In-Person Informal Meeting with Staff**

Based on the extent of the COVID-19 outbreak, the district may be confronted with not being able to provide face to face meetings between property owners and appraisal district staff/appraisers/chief appraiser to discuss the proposed value of your property. **We are encouraging you to consider appearing before the ARB by one of these alternate methods instead of personal appearance.**

- **Appearance by Affidavit** - either by letter on the form provided by the state (PTAD Form 50-283) that is available under the forms tab of the appraisal district's website: [www.campcad.org](http://www.campcad.org) or the PTAD website: <https://comptroller.texas.gov/forms/50-283.pdf>
- **Telephone Conference Call** – where you call in to the ARB hearing at a time assigned to you where you offer oral argument or testimony regarding your protest from the evidence you provide to the ARB prior to the hearing.

If you choose to exercise your right to a personal appearance before the ARB, your hearing will possibly be scheduled at a later date when social distancing requirements have been relaxed. However you choose to appear before the ARB, you will receive a notice of hearing at least fifteen days prior to the hearing date.
